TERMS OF PARTICIPATION

Upon the submission of the application form, the Exhibitor and the Organizer hereby agree as follows:

1. The Exhibitor's payment should be made in full (bank transfer fees incl.) via wire transfer in US dollar before Wednesday September 30, 2026 to the following destination bank coordinates:

2. The Exhibitor may begin to erect the booth starting from Wednesday, October 28th, and dismantle no earlier than Sunday, November 1st. Detailed schedule will follow prior to the event.

3. Should the Exhibitor cancel the booth after Friday, October 9th, the application fee shall be non-refundable.

4. The Exhibitor shall abide by rules and regulations of the organizer, the venue, the customs office and the regulatory body concerned.

5. The Organizer shall assist with the Exhibitor's liaison with the China National Convention Center when necessary.

6. The Organizer will provide a customs-supervised warehouse exclusively for the Exhibitor's products imported from outside the Chinese mainland that have been formally declared to the Chinese Customs, with 24-hour security monitoring. In the venue, the Exhibitor shall properly insure its goods against loss or damage and against liability for personal injury at its own expense. Neither the Organizer nor its agents or representatives will be responsible for any injury, loss or damage that may occur to the exhibitors or their property from any cause.

7. Neither Party shall be liable to the other Party for any delay or failure in the performance of services under this application form if such delay or failure in performance arise from any cause or causes beyond the reasonable control of the Party affected, including, but not limited to, acts of government or governmental authorities; compliance of laws, regulations or orders; pandemic; fire, storm, flood, or earthquake; war (declared or not), rebellion, revolution, or riots, strike, and/or lockout; provided that the affected Party has taken all reasonable steps to avoid or minimise the said effects, has promptly notified the other Party in writing of the details of the circumstance of Force Majeure, specifying its effects and estimated extent and duration, and immediately fulfils its outstanding obligations when the effects of the circumstances of Force Majeure have ended.

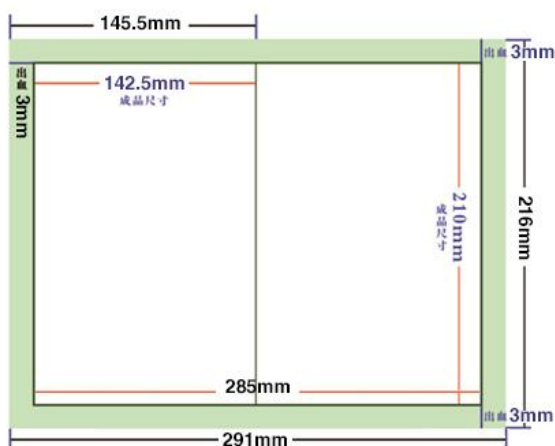
